Police Chief Justin Jobe presented the police report. They had 1,049 calls for service in 2016. There will be new in-car computer reporting to the federal government coming soon. Part-time officer Kyle Brown will be leaving the department soon after accepting a full-time deputy position with Watonwan County. He will be advertising for a new part-time employee.
