

The regular meeting of the Truman City Council was held December 18, 2017 at 5:30 p.m. The meeting was called to order by Mayor Brownlee

1. MINUTES

A motion was made by Mosloski, seconded by Ebert to approve the minutes of the last regular meeting held December 4, 2017. All yeas - carried.

2. SNOW PLOW TRUCK

Street Superintendent John Bosshart presented state bids on a new Freightliner chassis and a Crysteel box for a new snow plow truck. City Clerk Monte Rohman presented three quotes for a five year lease/purchase for the truck that would cost around \$144,000. Discussed the idea of using the existing 2002 snow plow. Also discussed a \$4,000 additional option to put a stainless steel box on it to eliminate rusting repairs in the future. Bosshart will get additional information for the next meeting.

3. LICENSES FOR 2018

A motion was made by Mosloski, seconded by Hendricksen to approve the issuance of the following licenses for 2018:

Aardvark's Bar & Grill: Games, music box, Sunday liquor, Intoxicating Off-Sale, Intoxicating On-sale; Casey's General Store: Tobacco; Hometown Sanitation, Hansen Sanitation, Waste Management and Madelia Sanitation: Garbage hauling. All yeas - carried.

4. CEMETERY MOWING CONTRACT

A motion was made by Mosloski, seconded by Ebert to approve a mowing contract with WDADS for \$2,640 per year to mow Ridgelawn Cemetery. All yeas - carried. WDADS will be paid \$220 per month.

5. LED STREET LIGHTS

A motion was made by Mosloski, seconded by Nickerson to approve the quote of \$13,162.50 from JT Services to purchase 65 LED street lights. All yeas - carried. The lights will be delivered in 2018 and will be the third year in a three year process to change all street lights to LED.

6. MONTHLY FINANCIAL REPORT

City Clerk Monte Rohman presented the November financial report and went over several line items.

A motion was made by Hendricksen, seconded by Ebert to approve the November, 2017 city financial reports. All yeas - carried.
