

The regular meeting of the Truman City Council was held April 15, 2019 at 5:30 p.m. The meeting was called to order by Brownlee

1. BOARD OF APPEAL AND EQUALIZATION

Deb Everson and Mike Sheplee were in attendance to discuss tax statements. Vern Quade was also present and wanted to know the process to have his property removed from city limits. Jan Firchau was also present as she felt her property value was too high. A motion was made by Ebert and seconded by Hendricksen for the Flower Shop to be reassessed.

2. N. 6th Ave. W.

Discussion regarding paving N. 6th Ave. W. took place the council decided that it wouldn't be fair to pave that road and not the others.

3. MINUTES

A motion was made by Ebert, seconded by Nickerson to approve the minutes of the last regular meetings and special meetings. All yeas - carried.

4. POOL

Faith Clow was present to discuss the pool. Early sign up will be May 8th 5-7pm at city hall. The pool will open June 1st. They will be changing water aerobics to 5:30pm instead of 5:00pm if this causes an issue it will be adjusted back. Clow also requested wood chips at the park. Ebert advised that the pool has heaved 3 to 4 inches and the frost isn't out of the ground yet. He proposed grinding and patching the deck and replace the concrete in the fall. Clow also questioned if the baseball association had paid for the use of the restrooms. One bid was received for pool deck repairs. A motion was made by Hendricksen and seconded by Nickerson to approve Truax's bid of \$40,268.75 with the option to make changes. A motion was made by Hendricksen and seconded by Nickerson to approve of purchasing the pool float.
